In order to activate this limited lifetime warranty you must return the completed warranty registration within 30 days after the product is picked up or delivered. This warranty is applicable to the original purchase and cannot be transferred to another party. Please read the below information in its entirety for the complete information about the warranty coverage.

### What Our Warranty Covers?

- Paint cracking (excluding the hardware)
- Peeling (excluding the hardware)
- Chipping (excluding the hardware)
- Factory defects

### What Our Warranty DOES NOT Cover?

- This warranty is not applicable in harsh environmental conditions, including marine or salty areas, or exposure to corrosive elements.
- Problems caused by improper installment
  - Damage due to altering the material, negligence, abuse, accident, or in transit
  - Appearance changes caused by normal weathering
  - Damage due to airborne chemicals or air pollution
  - Appearance changes caused by application of paint, chemicals, and varnish

Once this warranty is activated, Patriot Aluminum is limited to the repair or replacement of the defective material only, it does not cover reimbursement for the removal and reinstallation costs.

If the material has any of the above defects covered under warranty, the original purchaser must provide proof that the material installed is Patriot Aluminum products in addition to submitting this form in its entirety. Patriot Aluminum requires photos of the issue and a written description of the issue. If Patriot Aluminum deems the issue to be covered under warranty, the customer will receive a written notification and if it is not covered under warranty Patriot Aluminum can refuse the claim and charge the customer at their discretion.

This warranty cannot be modified, amended, or supplemented without written approval from Patriot Aluminum. No other agreement is valid, neither written or implied. Patriot Aluminum is the sole entity capable of expressing any kind of warranty.
